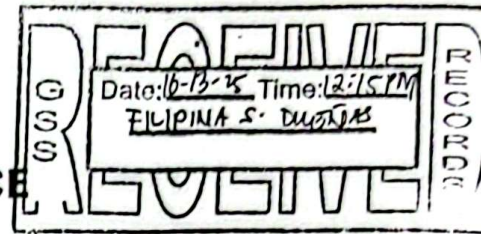

SUBJECT : **SUSPENSION OF MEMORANDUM CIRCULAR NO. VDM-2025-4674 OR THE PROHIBITION ON THE USE OF PROVISIONAL, IMPROVISED AND TEMPORARY PLATES**

In consideration of the reported unreleased plates by LTO Offices and accredited dealers, and to give ample time for license plates to be issued to motor vehicle owners, Memorandum Circular No. VDM-2025-4674 dated 25 September 2025 or the Prohibition on the use of Provisional, Improvised and Temporary Plates, is hereby **SUSPENDED** until further notice from this Office.

All other issuances inconsistent herewith are deemed repealed, revoked, and/or superseded accordingly.

**PROHIBITION ON THE USE OF PROVISIONAL, IMPROVISED
AND TEMPORARY PLATES**

DATE :

25 September 2025

Considering the absence of backlog in the production of motor vehicle license plates, continuous efforts to distribute license plates and in line with the nationwide implementation of Same Day Registration and Plate Release at the Point of Sale, on 15 October 2025, the use of provisional, improvised and temporary plates shall be prohibited upon effectivity of this Memorandum Circular.

The use of improvised plates shall be allowed, provided, that an authorization to use improvised plates shall be signed by the concerned LTO Office that processed the duplicate plate request. The improvised plate shall contain the assigned plate number of the vehicle, with the words "Improvised Plate" below it.

Before the effectivity of this Memorandum Circular, all concerned shall implement the provisions of Memorandum dated 27 August 2024, "Guidelines for the Implementation of VDM-2024-2721 on the Use of Improvised and Temporary Motor Vehicle (MV)/Motorcycle (MC) Plates", which is hereto attached.

Upon the effectivity of this Memorandum Circular, motor vehicles/motorcycles using provisional, improvised, and temporary plates without appropriate documentation shall:

1. Be apprehended for violation of Joint Administrative Order (JAO) 2014-001 and other existing laws, rules and regulations;
2. Not be accepted for renewal of MV/MC registration.

All issuances inconsistent herewith are deemed revoked, repealed, superseded, or amended accordingly.

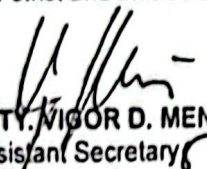
